




RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WHICH WAS AWARDED THROUGH A FAIR AND OPEN PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44A-20.5 ET SEQ. WITH ALFRED B. VUOCOLO, ESQ. TO PROVIDE PROSECUTORIAL SERVICES WITH REGARDS TO MATTERS CONCERNING THE TRENTON MUNICIPAL COURT IN AMOUNT NOT TO EXCEED \$9,460.00

WHEREAS, the City of Trenton has a continued need for prosecutorial services in the administrative office of the Trenton Municipal Court; and

WHEREAS, Resolution Number 16-465 awarded a contract to Alfred B. Vuocolo, Esq. in an amount not to exceed \$50,000.00 through RFP2016-18 for the period of July 1, 2016 through June 30, 2017; and

WHEREAS, previously allocated funds has been exhausted and additional funds are necessary to cover services rendered through June 30, 2017; and




AMENDMENT TO PROFESSIONAL LEGAL SERVICES AGREEMENT

THIS AMENDED AGREEMENT made this 31st day of October 2017, by and between the **CITY OF TRENTON**, a municipal corporation of the State of New Jersey, with its principal offices located at 319 East State Street, Trenton, New Jersey 08608 (herewith the ‘City’) and **ALFRED B. VUOCOLO, ESQUIRE**, 1083 Lawrence Road, Lawrenceville, New Jersey 08648 (hereinafter ‘Municipal Prosecutor’).

WHEREAS, based upon the number of hours which the Municipal Prosecutor has expanded in the 2017 fiscal contract year in the performance of municipal prosecutorial services on behalf of the City ; and

WHEREAS, the compensation initially allocated by the City to compensate the Municipal Prosecutor has been deemed to be insufficient to the end of the fiscal contract year; and


WHEREAS, pursuant to Resolution **17-699**, the City desires to increase the compensation under the current Professional Services Agreement for said services through June 30, 2017,

NOW THEREFORE, the parties mutually agree as follows:

1. The compensation amount of the Agreement shall be increased by an amount not to exceed (\$9,460.00)
2. All other provisions of the Professional Legal Services Agreement executed on July 1, 2016 shall remain in full force and effect.




