



RESOLUTION AUTHORIZING A FOUR (4) MONTH EXTENSION OF THE CONTRACT AWARDED TO BOYNTON & BOYNTON/ALLIANCE INSURANCE SERVICES, INC., 21 CEDAR AVENUE, FAIR HAVEN, NEW JERSEY 07704 TO CONTINUE COVERAGE FOR PROPERTY INSURANCE, AUTO LOT COVERAGE, FINE ARTS, AND FIDELITY BOND FOR THE CITY OF TRENTON FROM MARCH 1, 2019 TO JUNE 30, 2019 IN AN AMOUNT NOT TO EXCEED \$90,203.61- CC2018-02

WHEREAS, Resolution 18-240 awarded a contract to Boynton & Boynton/Alliant Insurance Services, Inc., 21 Cedar Avenue, Fair Haven, New Jersey 07707 to provide Broker Insurance Services for the City of Trenton for a period of one (1) year in an amount not to exceed \$75,000.00 with an option to extend two (2) one (1) extensions; and

WHEREAS, the existing insurance contract awarded to Boynton & Boynton/Alliant Insurance Services, Inc, 21 Cedar Avenue, Fair Haven, New Jersey 07704 property insurance, auto lot coverage, fine arts and fidelity bond coverage for the City of Trenton shall expire on March 1, 2019; and

WHEREAS, it is in the best interest of the City of Trenton to extend the contract with Boynton & Boynton/Alliant Insurance Services, Inc, for a period of four (4) months to secure property insurance coverage, auto lot, fine arts and fidelity bond from March 1, 2019 to June 30, 2019 until a new procurement is advertised by the Division of Purchasing, proposals are received and evaluated and a recommendation of award is made on or before June 30, 2019; and


WHEREAS, funds in the amount not to exceed \$ 90,203.61 have been certified to be available in the following account number: 9-01 80 8070-683 contingent upon the temporary and or final budget for FY'19. This amount will cover four (4) months of extended coverage from March 1, 2019 to June 30, 2019.



**FOUR (4) MONTH EXTENDED CONTRACT
RESOLUTION 19-130
WITH BOYNTON & BOYNTON/ALLIANCE INSURANCE SERVICES, INC.
CC2018-02**

THE AMENDED AGREEMENT made this 22ND day of MARCH 2019, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and (**BOYNTON & BOYNTON/ALLIANCE INSURANCE SERVICES, INC.**) with principal offices located **21 CEDAR AVENUE, FAIR HAVEN, NEW JERSEY 07704** (hereinafter "Professional Services").

WHEREAS, Resolution 18-240 awarded a contract to Boynton & Boynton/Alliant Insurance Services, Inc., 21 Cedar Avenue, Fair Haven, New Jersey 07707 to Continued Coverage for Property Insurance, Auto Lot coverage, Fine Arts, and Fidelity Bond for the City of Trenton for a period of one (1) year in an amount not to exceed \$75,000.00 with an option to extend two (2) one (1) extensions; and

WHEREAS, the existing insurance contract awarded to Boynton & Boynton/Alliant Insurance Services, Inc, 21 Cedar Avenue, Fair Haven, New Jersey 07704 property insurance, auto lot coverage, fine arts and fidelity bond coverage for the City of Trenton shall expire on March 1, 2019; and

WHEREAS, it is in the best interest of the City of Trenton to extend the contract with Boynton & Boynton/Alliant Insurance Services, Inc., 21 Cedar Avenue, Fair Haven, New Jersey 07707 for a period of four (4) to Continued Coverage for Property Insurance, Auto Lot coverage, Fine Arts, and Fidelity Bond from March 1, 2019 to June 30, 2019 until a new procurement is advertised by the Division of Purchasing, proposals are received and evaluated; and a recommendation of award is made on or before July 1, 2019; and


WHEREAS, Resolution 19-130 adopted on March 21, 2019, awarded a four (4) month contract extension to Boynton & Boynton/Alliant Insurance Services, Inc, 21 Cedar Avenue, Fair Haven, New Jersey 07704 to Continued Coverage for Property Insurance, Auto Lot coverage, Fine Arts, and Fidelity Bond for the City of Trenton, Department of Administration in an amount not to exceed \$90,203.61 from March 1, 2019 to June 30, 2019.

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with Boynton & Boynton/Alliant Insurance Services, Inc., 21 Cedar Avenue, Fair Haven, New Jersey 07707 to Continued Coverage for Property Insurance, Auto Lot coverage, Fine Arts, and Fidelity Bond for the City of Trenton, Department of Administration.
2. The amended contract shall remain in full force for four (4) months to renew in an amount not to exceed \$90,203.61 maintenance and shall not be extended without approval of the City Council of the City of Trenton.
