PROPOSAL FEE DEDUCT: The Base Proposal Fee includes the total cost of services to provide the scope defined in Section 3 of the Technical Proposal. This includes design, permitting, bidding, construction management, and resident inspection services for 3,900 lead service line replacements which is equivalent to 21% of the total number of lead services. TWW is currently obligated to replace 14% of lead service lines. We anticipate this number will increase as a result of future lead action level exceedances. In the event TWW's obligation for lead service line replacements remains at 14%, CDM Smith offers a deduct in the amount of \$415,000 to account for the reduction in scope. A breakdown of the deduct is \$43,000 for Task B1, \$11,300 for Task B2, \$186,000 for Task B3 and \$174,700 for Task B4. When applying the deduct, the Base Proposal Fee reduces to \$1,437,941
