RESOLUTION AMENDING RESOLUTION #19-334

WHEREAS, Resolution #19-334 passed on July 2, 2019, awarded multiple contracts to Dewcon, Inc., P.O. Box 439, Basking Ridge, New Jersey 07920, Waters & Bugbee, 75 S. Gold Drive, Hamilton, New Jersey 08691, and Ted Dolci, Inc., 340 Patterson Avenue, Trenton, New Jersey 08610 to provide Annual Water Service Repair, Replacement and Disconnect at the water main due, to water leaks, on an as needed basis for a period of one (1) year from June 21, 2019 to June 20, 2020 in an amount not to exceed \$401,848.50, for the Department of Water and Sewer and;

WHEREAS, the awarded amount on Resolution #19-334 was incorrect. The correct amount awarded should be \$600,000.00 and distributed as follows: (Dewcon, Inc. \$300,000.00), Waters & Bugbee, Inc. (\$180,000) and Ted Dolci (\$120,000.00); and

WHEREAS, funds in an amount not to exceed is \$600,000.00 have been certified to be available in the following account numbers: 9-05- -55-5500-835 and 0-05- -55-5500-835 and the funds will be available in the final adopted budget for the City of Trenton

NOW, THEREFORE IT IS RESOLVED, by the City Council of the City of Trenton that the amount of the contract award on Resolution #19-334 is hereby amended from \$401,848.50 to \$600,000.00 and is to be divided to multiple vendors for the City of Trenton, Department of Water and Sewer, for the said purpose in the manner prescribed by law.



WHEREAS, four (4) sealed bids were received on March 26, 2019, to provide Annual Water Service Repair, Replacement and Disconnect at the Water Main due to Water Leaks on an as needed basis; utilizing the three (3) lowest bidders for the City of Trenton, Department of Water and Sewer for a period of one (1) year from June 21, 2019 to June 20, 2020; and

WHEREAS, the bids of Dewcon, Inc., P.O. Box 439, Basking Ridge, New Jersey 07920, Waters & Bugbee, 75 S. Gold Drive, Hamilton, New Jersey 08691, and Ted Dolci, Inc., 340 Patterson Avenue, Trenton, New Jersey 08610, made pursuant to advertisement, be and are hereby accepted, as the lowest, legally responsible bidders complying with the terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$401,848.50 have been certified to be available in budget account number(s): 9-05- -55-5500-835 and 0-05- -55-5500-835 contingent upon the adoption of FY'2019 final budget and FY'2020 temporary or final budget, utilizing the three (3) lowest bidders.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute multiple contracts to Dewcon, Inc., P.O. **AMENDMENT TO RESOLUTION 19-603
WITH DEWCON, INC.
BID2019-18**

THE AMENDED AGREEMENT made this **6TH** day of **DECEMBER 2019**, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **DEWCON, INC., P.O. BOX 439, BASKING RIDGE, NEW JERSEY 07920** (hereinafter "Professional Services").

WHEREAS, Resolution 19-334 dated July 2, 2019, awarded a contract to multiple vendors to Provide Annual Water Service Repair, Replacement and Disconnect at the Water Main due to Water Leaks, on an as needed basis for a period of one (1) year from June 21, 2019 to June 20, 2020 in an amount not to exceed \$401,848.50, for the City of Trenton, Department of Water and Sewer per specifications filed in the Division of Purchasing; and

WHEREAS, Resolution No. 19-603, amended the awarded amount on Resolution #19-334; from \$401,848.50 to \$300,000.00 awarded to Dewcon, Inc., P.O. Box 439, Basking Ridge, New Jersey 07920.

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with Dewcon, Inc., P.O. Box 439, Basking Ridge, New Jersey 07920 to Provide Annual Water Service Repair, Replacement and Disconnect at the Water Main due to Water Leaks, on an as needed basis for the City of Trenton, Department of Water and Sewer in an amount not to exceed \$300,000.00.
2. The amended contract shall remain in full force from June 21, 2019 to June 20, 2020 and shall not be extended without approval of the City Council of the City of Trenton.
