WHEREAS, Resolution Number 18-750 adopted on December 6th, 2018, awarded to FCC Consulting Services, Inc., 39 Birmingham Drive, Columbus, New Jersey 08022 for Operations, Management or Administration of Data Processing Services for three (3) years in an amount not to exceed \$2,403,964.00 with an option to extend year (4) and year (5) for the City of Trenton, Department of Administration, Division of Information Technology; and

WHEREAS, it is in the best interest of the City of Trenton, Department of Administration to authorize a three extension to FCC Consulting Services, Inc., 39 Birmingham Drive, Columbus, New Jersey 08022 from January 1, 2020 to March 31, 2020 or until the proposals received have been evaluated, a recommendation of award has been made, a resolution adopted and a new contract is in place; and

WHEREAS, funds in an amount not to exceed \$73,710.00 per month have been certified to be available in account number: 0-01- -25-2540-290.

RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR ONE (1) YEAR AWARDED TO FCC CONSULTING SERVICES, LLC, 39 BIRMINGHAM DRIVE, COLUMBUS, NEW JERSEY 08022 FOR THE OPERATION, MANAGEMENT OR ADMINISTRATION OF DATA PROCESSING SERVICES FOR THE DEPARTMENT OF ADMINISTRATION, DIVISION OF INFORMATION TECHNOLOGY FROM JANUARY 1, 2019 TO DECEMBER 31, 2019 IN AN AMOUNT NOT TO EXCEED \$850,500.00 – CC2015-06

WHEREAS, Resolution 15-705 awarded a contract on December 17, 2015 to FCC Consulting Services, LLC, 39 Birmingham Drive, Columbus, New Jersey 08022 for the Operation, Management, or Administration of Data Processing Services for a period three (3) years in the amount of \$2,403,964.00 with the Option to Extend Year (4) and Option to Extend Year five (5) for the City of Trenton for the Department of Administration, Division of Information Technology; and

WHEREAS, The City of Trenton, Department of Administration has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year to FCC Consulting Services, LLC, 39 Birmingham Drive, Columbus, New Jersey 08022 in an amount not exceed \$850,500.00; and

WHEREAS, funds in an amount not to exceed \$850,500.00, from January 1, 2019 to June 30, 2019, (\$425,250.00) have been certified to be available in account 09-01- -25-2540-290 and from July 1, 2019 to December 30, 2019 (\$425,250.00) available in account 10-01- -25-2540-290 contingent upon the adoption FY'2019 and FY'2020 temporary and or final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the option to extend the contract for the fourth (4th) year with FCC Consulting Services, LLC, 39 Birmingham Drive, Columbus, New Jersey 08022 in an amount not to exceed \$850,500.00 for the City of Trenton, Department of Administration, Division of Information Technology for the said purposes in the manner prescribed by law.

**AGREEMENT
RESOLUTION # 20-81
THREE (3) MONTH CONTRACT EXTENSION
WITH FCC CONSULTING SERVICES, INC.
CC2015-06**

THE AGREEMENT made this 7TH day of FEBRUARY 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **FCC CONSULTING SERVICES, INC., 39 BIRMINGHAM DRIVE, COLUMBUS, NEW JERSEY 08022** (hereinafter "CONTRACTOR")

WHEREAS, Resolution Number 18-750 adopted on December 6th, 2018, awarded to FCC Consulting Services, Inc., 39 Birmingham Drive, Columbus, New Jersey 08022 for Operations, Management or Administration of Data Processing Services for three (3) years in an amount not to exceed \$2,403,964.00 with an option to extend year (4) and year (5) for the City of Trenton, Department of Administration, Division of Information Technology; and

WHEREAS, Resolution #20-81 determined it is in the best interest of the City of Trenton, Department of Administration to authorize a three (3) month contract extension to FCC Consulting Services, Inc., 39 Birmingham Drive, Columbus, New Jersey 08022 from January 1, 2020 to March 31, 2020 or until the proposals received have been evaluated, a recommendation of award has been made, a resolution adopted and a new contract is in place; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$73,710.00 per month for the City of Trenton, Department of Administration, Division of Information Technology from January 1, 2020 to March 31, 2020.
2. The Mayor is hereby authorized to enter into a contract extension for three (3) months from January 1, 2020 to March 31, 2020 with FCC Consulting Services, Inc., 39 Birmingham Drive, Columbus, New Jersey 08022 in an amount not to exceed \$73,710.00 per month 08022 for Operations, Management or Administration of Data Processing Services for the City of Trenton, Department of Administration, Division of Information Technology for the said purposes in the manner prescribed by law.
