


**RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH THE LAW OFFICE OF INGLESINO, WEBSTER, WYCISKALA & TAYLOR, LLC, 600 PARSIPPANY ROAD, SUITE 204, PARSIPPANY NEW JERSEY 07054 TO PROVIDE CONTINUED PROFESSIONAL LEGAL SERVICES REGARDING GENERAL MUNICIPAL AND DEFENSE LITIGATION MATTERS IN AN AMOUNT NOT TO EXCEED \$25,000.00**

**WHEREAS**, the City of Trenton has a continuing need for professional legal services regarding General Municipal and Defense Litigation matters; and

**WHEREAS**, Resolution Number 19-252 awarded a contract to the Law Office of Inglesino, Webster, Wyciskala & Taylor, LLC through RFP219-16 in an amount not to exceed \$25,000.00; and

**WHEREAS**, previously allocated funds have been exhausted and additional funds in the amount of \$25,000.00 are necessary to cover services through June 2020 which will bring to total contract amount to \$50,000.00; and





**AMENDMENT TO PROFESSIONAL LEGAL SERVICES AGREEMENT**

THIS AMENDED AGREEMENT made this 23<sup>rd</sup> day of January 2020, by and between the CITY OF TRENTON, a municipal corporation of the State of New Jersey, with its principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and JOHN P. INGLESINO, ESQ., Inglesino, Webster, Wyciskala & Taylor, LLC, 600 Parsippany Road, Suite 204, Parsippany, New Jersey 07054 (hereinafter "Law Firm").

WHEREAS, based upon the number of hours which Law Firm has expended in the 2019 fiscal contract year in the performance of general and municipal litigation defense on behalf of the City; and

WHEREAS, the compensation initially allocated by the City to compensate the Law Firm has been deemed to be insufficient to the end of the fiscal contract year; and

WHEREAS, pursuant to Resolution 20-56, the city desires to increase the compensation under the current Professional Services Agreement for said services through June 30, 2020,

NOW THEREFORE, the parties mutually agree as follows:

1. The compensation in the amount of the Twenty-Five Thousand Dollars (\$25,000.00) represents an amendment to the funds of the original contract awarded on August 12, 2019, which brings the total contract award amount to \$50,000.00 for services through June 30, 2020.
