





## RESOLUTION AUTHORIZING CONTRACT AMENDMENT NO. 1 TO JASON F. HAGEMAN, ESQUIRE-RFP-2019-25

**WHEREAS**, Resolution #19-341 was adopted and awarded on July 2, 2019, through a fair and open process in accordance per N.J.S.A. 19:44 A-20.4 ET SEQ to Jason F. Hageman, Esq., 269 Challin Avenue, Trenton, New Jersey, 08638 to provide professional Public Defender Services at Trenton Municipal Court for a period of July 1, 2019 to June 30, 2020 in an amount not exceed in \$52,000; and

**WHEREAS**, Contract Amendment No. 1 to bring the total price of the contract from \$52,000 to \$92,625 to continue to provide Public Defender Services for the Public Defender Office. The Public Defender Office covers (96) ninety six sessions monthly. The Public Defenders under contract will be scheduling additional sessions, Co-Defendant cases/sessions, video conferencing sessions with State facilities, and other matters that may arise. The Total amount of the contract will be \$92,625; and

**WHEREAS**, funds in an amount not to exceed \$40,625 have been certified to be available in account number 0-01- -25-2520-290 at the rate of \$210.00 per session contingent upon adoption of FY' 2020 final budget; and

**NOW, THEREFORE IT IS RESOLVED**, by the City Council of the City of Trenton that the Mayor is hereby authorized to amend contract with Jason F. Hageman, Esq for the said purposes in the manner prescribed by law.

**RESOLUTION AWARDDING A CONTRACT THROUGH A FAIR AND OPEN PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44 A-20.4 ET SEQ TO THE LAW OFFICE OF JASON F. HAGEMAN, ESQ., 269 CLAFLIN AVENUE, TRENTON, NEW JERSEY 08638 TO PROVIDE PROFESSIONAL PUBLIC DEFENDER SERVICES AT TRENTON MUNICIPAL COURT FOR A PERIOD OF ONE (1) YEAR FROM JULY 1, 2019 TO JUNE 30, 2020 IN AN AMOUNT NOT TO EXCEED \$52,000.00- RFP2019-25**

**WHEREAS**, the City of Trenton has a need for Public Defender Services for the Department of Administration, Division of Public Defender's Office; and

**WHEREAS**, a request for proposal was advertised, and five (5) proposals were received on April 25, 2019, and were evaluated by a committee based on criteria that included experience, understanding of requirements and cost; and

**WHEREAS**, the proposal of The Law Office of Jason F. Hageman, Esq., 269 Claflin Avenue, Trenton, New Jersey 08638 was deemed to include the necessary qualifications and expertise for the performance of the services; and

**WHEREAS**, funds in an amount not to exceed \$52,000.00 have been certified to be available in account number 0-01- -25-2520-290 at the rate of \$210.00 per session from July 1, 2019 to June 30, 2020 contingent upon adoption of FY' 2020 temporary and or final budget.


**NOW, THEREFORE IT IS RESOLVED**, by the City Council of the City of Trenton, as follows:



**AMENDMENT TO RESOLUTION 20-115  
WITH THE LAW OFFICE OF NANCY R. GARZA  
RFP2019-25**

**THE AMENDED AGREEMENT** made this 6TH day of **MARCH 2020**, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **THE LAW OFFICE OF JASON F. HAGEMAN, ESQ., 269 CHAFLIN AVENUE, TRENTON, NEW JERSEY 08638** (hereinafter "Professional Services").

**WHEREAS**, Resolution **19-341** was adopted and awarded on July 2, 2019, through a fair and open process in accordance per N.J.S.A. 19:44 A-204 Et. Seq to The Law Office of Jason F. Hageman, Esq., 269 Chaffin Avenue, Trenton, New Jersey 08638 to provide professional Public Defender Services at Trenton Municipal Court for a period of one (1) year from July 1, 2019 to June 30, 2020 in an amount not to exceed \$52,000.00; and

**WHEREAS**, Contract Amendment No. 1 to bring the total price of the contract from \$52,000.00 to \$92,625.00 to continue to provide Public Defender Services for the Public Defender Office. The Public Defender Office covers (96) ninety-six sessions monthly. The Public Defender under contract will be scheduling additional sessions, Co-Defendant cases/sessions, video conferencing sessions with State facilities and other matters that may arise. The total amount of the contract will be \$92,625.00; and


**WHEREAS**, Resolution No. 20-115, amended the awarded amount on Resolution #19-340; from \$52,000.00 to \$92,625.00 awarded to The Law Office of Jason F. Hageman, Esq., 269 Chaffin Avenue, Trenton, New Jersey 08638; and

**NOW THEREFORE**, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with The Law Office of Jason F. Hageman, Esq., 269 Chaffin Avenue, Trenton, New Jersey 08638 to Provide Public Defender Services for the City of Trenton, Department of Administration, Division of Public Defender's Office in an amount not to exceed \$40,625.00 at an hourly rate of \$210.00 per session.
2. The amended contract shall remain in full force from March 6, 2020 to March 5, 2021 and shall not be extended without approval of the City Council of the City of Trenton.
