**RESOLUTION AWARDING A CONTRACT TO CORE MECHANICAL
AWARDED THROUGH NEW JERSEY STATE CONTRACT NO. T-1372 A88697
IN AN AMOUNT NOT TO EXCEED \$499,352.24**

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items and provide services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No.# T-1372 A88697 for HVAC, Refrigeration and Boiler Services awarded to Core Mechanical, 7905 Browning Road, Suite 110, Pennsauken, New Jersey 08109 from March 1, 2015 to February 29, 2020 meeting the requirements of the City of Trenton, Department of Public Works, Division of Public Property; and

WHEREAS, Core Mechanical, 7905 Browning Road, Suite 110, Pennsauken, New Jersey 08109 shall provide preventive maintenance and repairs to heating and air conditioning equipment for city facilities which meets the department's requirements awarded through New Jersey State Contract No. # T-1372 A88697 in an amount not to exceed of \$499,352.24 for the City of Trenton, Department of Public Works, Division of Public Property; and

WHEREAS, This contract will cover major repairs and replacement as well as continual preventive maintenance needed to sustain equipment and provide adequate heating and cooling to City facilities.

WHEREAS, funds in an amount not to exceed \$499,352.24 have been certified to be available in account numbers(s): 0-01- -55-5530-280 (\$400,00.00), C-04-08-65-079A-013 (\$60,055.93), C-04-18-55-030A-001 (\$20,016.31), and C-04-18-55-030A-001 (\$19,280.00) from December 1, 2019 to February 29, 2020. This contract will be utilized for preventive maintenance and repairs to heating and air conditioning equipment in city facilities.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$499,352.24 for preventive maintenance and repairs to heating and air conditioning equipment for city facilities awarded through New Jersey State Contract No. T-1372 A88697 to Core Mechanical, 7905 Browning Road, Suite 110, Pennsauken, New Jersey 08109 for the City of Trenton, Department of Public Works, Division of Public Property.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.


