

**AGREEMENT

CONTRACT EXTENSION
WITH BCHG
BID2019-10**

THE AGREEMENT made this 7TH day of JULY 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **BCHG, 747 CHERRY STREET, SOUTHAMPTON, NEW JERSEY 08088** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 19-227 awarded a contract on June 6, 2019, to BCHG, 747 Cherry Street, Southamton, New Jersey 08088 for Potable Water Residuals Disposal, Blending and Beneficial Reuse in an amount not to exceed \$491,000.00 at \$65.00 unit price per ton for (7,500 tons)= \$487,500.00 plus laboratory fees \$3,500.00 for a period of one (1) year from June 7, 2019 to June 6, 2020; with an option to extend for one (1) year from June 7, 2020 to June 6, 2021 for the City of Trenton, Department of Water and Sewer, Water Filtration Plant; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer, Water Filtration Plant has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to exercise the option to extend the contract for a period of one (1) year from June 7, 2020 to June 6, 2021 to BCHG, 747 Cherry Street, Southamton, New Jersey 08088 in an amount not exceed \$491,000.00; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$491,000.00 at \$65.00 unit price per ton for (7,500.00)=\$487,500.00 plus laboratory fees \$3,500.00 for the City of Trenton, Department of Water and Sewer, Water Filtration Plant from June 7, 2020 to June 6, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for the second (2nd) year from June 7, 2020 to June 6, 2021 with BCHG, 747 Cherry Street, Southamton, New Jersey 08088 in an amount not to exceed \$491,000.00 at \$65.00 unit price per ton for (7,500.00)=\$487,500.00 plus laboratory fees \$3,500.00 for Potable Water Residuals Disposal, Blending and Beneficial Reuse for the City of Trenton for the City of Trenton, Department of Water and Sewer, Water Filtration Plant for the said purposes in the manner prescribed by law.
