

**AGREEMENT

CONTRACT EXTENSION
WITH SUPERION, LLC
BID2018-54**

THE AGREEMENT made this **6TH day of AUGUST 2020**, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **SUPERION, LLC, 1000 BUSINESS CENTER DRIVE, LAKE MARY, FLORIDA 32746** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 18-549 awarded a contract on June 8, 2018, to Superior, LLC, 1000 Business Center Drive, Lake Mary, Florida 32746 for Maintenance and Support on the OSSI/Sungard Integrated 911 System. This contract was awarded for a period of two (2) years in amount not to exceed \$569,895.10 for the City of Trenton, Police Department; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, the City of Trenton, Department of Police has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of two (2) years to Superior, LLC, 1000 Business Center Drive, Lake Mary, Florida 32746 in an amount not to exceed \$569,895.10 from July 1, 2020 to June 30, 2022; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$569,895.10 for the City of Trenton, Police Department from July 1, 2020 to June 30, 2022.
2. The Mayor is hereby authorized to enter into a contract extension with Superior, LLC, 1000 Business Center Drive, Lake Mary, Florida 32746 for Maintenance and Support on the OSSI/Sungard Integrated 911 System for a period of two (2) years in an amount not to exceed \$569,895.10 for the City of Trenton, Department of Police for the said purposes in the manner prescribed by law.



This contract was awarded for a period of two (2) years in an amount not to exceed \$497,768.45 with an option to extend two (2) years in an amount not to exceed \$569,895.10 for the City of Trenton, Police Department; and
