CONTRACT EXTENSION
WITH THE K STREET GROUP
BID2019-39**

THE AGREEMENT made this 1st day of OCTOBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **THE K STREET GROUP, 1220 STATE ROUTE 31, SUITE #15, LEBANON, NEW JERSEY 08833** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 19-410 awarded a contract on October 3, 2019, to The K Street Group, 1220 State Route 31, Suite #15, Lebanon, New Jersey 08833 to Provide Armed Security Guard Services at Trenton Water Filtration Plant in an amount not to exceed \$249,600 for a period of one (1) year (for 24 hours, 7 days per week at \$28.50 per hour) from July 1, 2019 to June 30, 2020; with an option to extend for one (1) year from July 1, 2020 to June 30, 2021 for the City of Trenton, Department of Water and Sewer, Division of Water Filtration Plant; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer, Water Filtration Plant has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to exercise the option to extend the contract for a period of one (1) year from July 1, 2020 to June 30, 2021 to The K Street Group, 1220 State Route 31, Suite #15, Lebanon, New Jersey 08833 in an amount not exceed \$252,025.20 (for 24 hours, 7 days per week at \$28.77 per hour); and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$252,025.20 (for 24 hours, 7 days per week at \$28.77 per hour) for the option to extend one (1) year for the City of Trenton, Department of Water and Sewer, Water Filtration Plant from July 1, 2020 to June 30, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for the second (2nd) year from July 1, 2020 to June 30, 2021 with The K Street Group, 1220 State Route 31, Suite #15, Lebanon, New Jersey 08833 in an amount not to exceed \$252,025.20 (for 24 hours, 7 days per week at \$28.77 per hour) to Provide Armed Security Guard Services at Trenton Water Filtration Plant for the City of Trenton, Department of Water and Sewer, Water Filtration Plant for the said purposes in the manner prescribed by law.




