

**AMENDMENT TO RESOLUTION 20-726
WITH THE LAW OFFICE OF FLORIO, KENNY & RAVAL, LLP
RFP2019-16**

THE AMENDED AGREEMENT made this **25TH** day of **NOVEMBER 2020**, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **THE LAW OFFICE OF FLORIO, KENNY & RAVAL, LLP, 125 CHUBB AVENUE, SUITE 310N, LYNDHURST, NEW JERSEY 07071** (hereinafter "Professional Services").

WHEREAS, Resolution 19-420 was adopted and awarded on August 1, 2019, through a fair and open process in accordance per N.J.S.A. 19:44 A-204 Et. Seq to The Law Office of Florio, Kenny & Raval, LLP, 125 Chubb Avenue, Suite 310N, Lyndhurst, New Jersey 07071 to Provide Professional Legal Services Regarding General Municipal and Other Legal Matters in an amount not to exceed \$25,000.00 and structured at the hourly rate as follows, \$175.00 for Partners, \$135.00 for Associate Attorneys and \$85.00 for Paralegals for a period of one (1) year from July 1, 2019 to June 30, 2020; and

WHEREAS, Contract Amendment No. #1, and Resolution No. 20-55, amended the contract on February 6, 2020 due to previously allocated funds being exhausted and a contract amendment in the amount of \$35,000.00 is necessary to cover services through June 2020 which will bring the total contract amount to \$60,000.00; and

WHEREAS, previously allocated funds have been exhausted and a contract amendment in the amount of \$9,869.50 is necessary to cover services rendered through June 2020 which will bring the contract total amount to \$69,869.50; and

WHEREAS, Contract Amendment No. #2 to bring the total price of the contract from \$60,000.00 to \$69,869.50 to continue to provide Professional Legal Services Regarding General Municipal and Other Legal Matters; and

WHEREAS, Resolution No. 20-726, amended the awarded amount on Resolution #20-55; from \$60,000.00 to \$69,869.50 awarded to The Law Office of Florio, Kenny & Raval, LLP, 125 Chubb Avenue, Suite 310N, Lyndhurst, New Jersey 07071; and


NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with The Law Office of Florio, Kenny & Raval, LLP, 125 Chubb Avenue, Suite 310N, Lyndhurst, New Jersey 07071 to continue to provide Professional Legal Services Regarding General Municipal and Other Legal Matters for the City of Trenton, Department of Law in an amount not to exceed \$69,869.50 at the hourly rate as follows, \$175.00 for Partners, \$135.00 for Associate Attorneys and \$85.00 for Paralegals.
2. The amended contract shall remain in full force from July 1, 2020 to June 30, 2021 and shall not be extended without approval of the City Council of the City of Trenton.





WHEREAS, funds in an amount not to exceed \$25,000.00 have been certified to be available contingent upon temporary or final adoption of the FY2020 Budget in Account No. 0-01- -35-3500-290 for the period of July 1, 2019 through June 30, 2020.
