

**AMENDED CONTRACT TO RESOLUTION 20-723  
WITH THE LAW OFFICE OF BOYLE & VALENTI LAW, PC  
RFP2020-20**

THE AMENDED AGREEMENT made this 25TH day of NOVEMBER 2020, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **THE LAW OFFICE OF BOYLE & VALENTI LAW, P.C., 10 GROVE STREET, HADDENFIELD, NEW JERSEY 08033** (hereinafter "Professional Services").

WHEREAS, Resolution 20-347 was adopted and awarded on July 2, 2020, through a fair and open process in accordance per N.J.S.A. 19:44 A-204 Et. Seq to The Law Office of Boyle & Valenti Law, P.C., 10 Grove Street, Haddenfield, New Jersey 08033 for Professional Legal Services in regards to Legal Representation for City Council Members of the City of Trenton for a period of one (1) year from July 1, 2020 to June 30, 2021 in an amount not to exceed \$20,000.00; and

WHEREAS, previously allocated funds have been exhausted and a contract amendment in the amount of \$30,000.00 is necessary to cover services for Professional Legal Services regarding Legal Representation for City Council Members through June 2021; and

WHEREAS, Contract Amendment No. 1 to bring the total price of the contract from \$20,000.00 to \$30,000.00 to continue Professional Legal Services regarding Legal Representation for City Council Members. The grand total amount for this contract is \$50,000.00; and

WHEREAS, Resolution No. 20-723, amended the awarded amount on Resolution #20-347; from \$20,000.00 to \$30,000.00 awarded to The Law Office of Boyle & Valenti Law, P.C., 10 Grove Street, Haddenfield, New Jersey 08033 until June 30, 2021; and

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with The Law Office of Boyle & Valenti Law, P.C., 10 Grove Street, Haddenfield, New Jersey 08033 to continue to Provide Professional Legal Services in regards to Legal Representation for City Council Members an amount not to exceed \$30,000.00. The grand total of this contract is \$50,000.00.
2. The amended contract shall remain in full force from July 1, 2020 to June 30, 2021 and shall not be extended without approval of the City Council of the City of Trenton.



WHEREAS, request for proposals were advertised on the City website and Twelve (12) proposals were received and opened in the City Purchasing Office at 11:00 AM on June 3, 2020; and

WHEREAS, the evaluation committee has reviewed the proposals submitted and has recommended that a contract be awarded to Boyle & Valenti Law, PC in an amount not to exceed \$20,000.00 and structured at the hourly rates as follow, \$175.00 for Partners, \$135.00 for Associate Attorneys and \$85.00 for Paralegals; and




**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton, as follows:
