

**AGREEMENT

OPTION TO EXTEND CONTRACT FOR ONE (1) YEAR
WITH HENRY J. AUSTIN HEALTH CENTER
CC2019-08
FOR PROVISIONS OF COMPREHENSIVE PRIMARY HEALTH CARE SERVICES TO UNDERINSURED
AND UNINSURED RESIDENTS FOR THE CITY OF TRENTON**

THE AGREEMENT made this 11TH day of DECEMBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **HENRY J. AUSTIN HEALTH CENTER, 321 N. WARREN STREET, TRENTON, NEW JERSEY 08618-0471** (hereinafter "CONTRACTOR")

WHEREAS, Resolution Number 20-64 awarded a contract on February 6, 2020, to Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 for Provisions of Comprehensive Primary Health Care Services to Underinsured and Uninsured Residents of the City of Trenton for a period of one (1) year from October 18, 2019 to October 17, 2021 in an amount not to exceed \$259,000.00 per year with an option to extend two (2) one (1) year extensions AT \$259,000.00 per year for the City of Trenton, Department of health and Human Services; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, the City of Trenton, Department of Health and Human Services, has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year from October 18, 2020 to October 17, 2021 to Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 in an amount not to exceed \$259,000.00; and

NOW THEREFORE, the parties mutually agree as follows:


1. The amount of the agreement shall be in an amount not to exceed \$259,000.00 with the option to extend the second (2nd) year for the City of Trenton, Department of Health and Human Services from October 18, 2020 to October 17, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for one (1) year from October 18, 2020 to October 17, 2021 with Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 in an amount not to exceed \$259,000.00 for Provisions of Comprehensive Primary Health Care Services to Underinsured and Uninsured Residents of the City of Trenton, Department of Health and Human Services for the said purposes in the manner prescribed by law.

RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR A PERIOD OF ONE (1) YEAR TO HENRY J. AUSTIN HEALTH CENTER FOR PROVISIONS OF COMPREHENSIVE PRIMARY HEALTH CARE SERVICES TO UNDERINSURED AND UNINSURED RESIDENTS IN AN AMOUNT NOT TO EXCEED \$259,000.00 PER YEAR- CC2019-08

WHEREAS, Resolution Number 2064 awarded a contract on February 6, 2020, to Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 for Provisions of Comprehensive Primary Health Care Services to Underinsured and Uninsured Residents of the City of Trenton for a period of one (1) year from October 18, 2019 to October 17, 2021 in an amount not to exceed \$259,000.00 per year with an option to extend two (2) one (1) year extensions for the City of Trenton, Department of health and Human Services; and

WHEREAS, pursuant to N.J.S.A. 40A-11-15 provides that service contracts may be extended for no more than one (1) two-year or (2) two one-year extensions; and

WHEREAS, the City of Trenton, Department of Health and Human Services, has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year from October 18, 2020 to October 17, 2021 to Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 in an amount not to exceed \$259,000.00; and

WHEREAS, funds in an amount not to exceed \$259,000.00 with the option to extend the second (2nd) year from October 18, 2020 to October 17, 2021 have been certified to be available in the following account number: 1-01- -40-4022-290 (\$259,000.00) and 2-01- -40-4022-290 (\$259,000.00).

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to exercise the option to extend the contract for one (1) year from October 18, 2020 to October 17, 2021 with Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 in an amount not to exceed \$259,000.00 for Provisions of Comprehensive Primary Health Care Services to Underinsured and Uninsured Residents of the City of Trenton, Department of Health and Human Services for the said purposes in the manner prescribed by law.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.

WARREN STREET, TRENTON, NEW JERSEY 08618-0471 FOR PROVISIONS OF COMPREHENSIVE PRIMARY HEALTH CARE SERVICES TO UNDERINSURED AND UNINSURED RESIDENTS OF THE CITY OF TRENTON, NEW JERSEY IN AN AMOUNT NOT TO EXCEED \$259,000.00- CC2019-08

WHEREAS, the City of Trenton, Department of Health and Human Services has a need for Provisions of Comprehensive Primary Health Care Services to Underinsured and Uninsured Residents of the City of Trenton, New Jersey for a period of one (1) year with an option to extend two (2) one (1) year extensions for the City of Trenton, Department of Health and Human Services; and

WHEREAS, a Competitive Contracting Request for Proposal was advertised, and one (1) proposal was received on September 5, 2019, and was evaluated by a committee based on criteria that included, experience, understanding of requirements and cost; and

WHEREAS, the sole proposal received from Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 deemed to include the necessary qualifications and expertise for the performance of the services at the rates listed in the proposal; and

WHEREAS, funds in an amount not to exceed \$259,000.00 for a period of one (1) year shall be available in the following account number(s): 0-01-40-4022-290 from October 18, 2019 to October 17, 2020 with an option to extend two (2) one (1) year extensions (2nd year \$259,000.00 and 3rd year \$259,000.00); funds will be available in the final adopted budget for the City of Trenton.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Mayor is hereby authorized to enter into a contract with Henry J. Austin Health Center, 321 N. Warren Street, Trenton, New Jersey 08618-0471 for Provisions of Comprehensive Primary Health Care Services to Underinsured and Uninsured Residents for a period of one (1) year with an option to extend two (2) one (1) year extensions for the City of Trenton, Department of Health and Human Services.
2. This contract is awarded pursuant to the authority set forth in the Local Public Contracts Law at N.J.S.A. 40A:114.1(k)
3. A notice of this action shall be printed once in the official newspaper for the City of Trenton and the Resolution and contract shall remain on file in the City Clerk's Office.
