

**RESOLUTION # 20-745
CHANGE ORDER #1
BID2019-77**

THE AGREEMENT made this 23RD day of DECEMBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **LAMANNA ELECTRIC, INC., P.O. BOX 9348, TRENTON, NEW JERSEY 08650** (hereinafter "CONTRACTOR")

WHEREAS, Resolution 20-70 awarded a contract on February 6, 2020, to Lamanna Electric, Inc., P.O. Box 9348, Trenton, New Jersey 08650 for the Purchase and Installation of One (1) Generac Industrial Gaseous 175W natural Gas Engine Driven Generator or Equivalent for the City of Trenton, Department of Public Works, Division of Traffic and Transportation; Work shall be completed within sixty (60) calendar days from "Notice to Proceed" in an amount not to exceed \$139,500.00; and

WHEREAS, Resolution No. #20-745 dated December 23, 2020, authorized Change Order No. #1 in an amount not to exceed \$3,500.00 for the City of Trenton, Department of Public Works, Division of Traffic and Transportation; during the performance of the contract PSE&G required the city to alter the existing gas meter piping and install a pressure regulator; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of change order #1 shall be in an amount not to exceed \$3,500.00. The changes will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and
2. The Mayor is hereby authorized Change Order No. #1 with Lamanna Electric, Inc., P.O. Box 9348, Trenton, New Jersey 08650 for said purposes in the manner prescribed by law. The grand total of the project in an amount not to exceed \$139,500.00 and the change order #1 in an amount not to exceed \$3,500.00 for a grand total of \$143,000.00




WHEREAS, the amount of this change order is \$3,500.00. The total amount of this change order is less than 20% of the original contract amount; and
