OPTION TO EXTEND CONTRACT
WITH MUNICIPAL MAINTENANCE, CO.,
BID2019-60
MAINTENANCE ON AIR VACUUM HANDLING EQUIPMENT**

THE AGREEMENT made this 11th day of DECEMBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **MUNICIPAL MAINTENANCE, CO., 1352 TAYLOR LANE, CINNAMINSON, NEW JERSEY 09077** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 19-609 awarded a contract on November 14, 2019, to Municipal Maintenance, 1352 Taylor Lane, Cinnaminson, New Jersey 09077 for the Maintenance on Air Vacuum Handling Equipment in an amount not to exceed \$18,130.00 for items#1-5 from November 15, 2019 to November 14, 2020; with an option to extend for one (1) year in an amount not to exceed \$22,090.00 for items#1-5 for the City of Trenton, Department of Water and Sewer; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer, Water Utility, Water Filtration Plant has determined that the vendor has performed its maintenance on air vacuum handling equipment in a satisfactory manner and it is in the best interest of the City to exercise the option to extend the contract for a period of one (1) year from November 15, 2020 to November 14, 2021 to Municipal Maintenance, 1352 Taylor Lane, Cinnaminson, New Jersey 09077 in an amount not exceed \$22,090.00 for item#1-5; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$22,090.00 for items#1-5 for the City of Trenton, Department of Water and Sewer from November 15, 2020 to November 14, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for one (1) year from October 29, 2020 to November 14, 2021 with Municipal Maintenance, 1352 Taylor Lane, Cinnaminson, New Jersey 09077 in an amount not to exceed \$22,090.00 for the Maintenance on Air Vacuum Handling Equipment of Trenton, Department of Water and Sewer for the said purposes in the manner prescribed by law.





