CHANGE ORDERS #1 AND 2 FOR RENOVATION OF THE READING SENIOR RECREATION CENTER, 15 RINGOLD STREET, TRENTON, NJ WITH LEVY CONSTRUCTION COMPANY, INC. AND THE CITY OF TRENTON, DEPARTMENT OF HOUSING AND ECONOMIC DEVELOPMENT

THE AGREEMENT made this 19<sup>th</sup> day of MARCH 2021, by and between the CITY OF TRENTON, a municipal corporation, of the State of New Jersey, with principal offices located at 319 EAST STATE STREET, TRENTON, NEW JERSEY 08608 (hereinafter the "City") and LEVY CONSTRUCTION COMPANY, INC., 134 CUTHBERT BLVD., AUDUBON, NEW JERSEY 08106 (hereinafter "CONTRACTOR")

WHEREAS, Resolution 20-487 awarded a contract on October 1, 2020, to Levy Construction Company, Inc., 134 Cuthbert Blvd., Audubon, New Jersey 08618 for Reading Senior Center Improvements, 15 Ringold Street, Trenton, New Jersey 08618 for the City of Trenton, Department of Housing and Economic Development in an amount not to exceed \$651,600.00; Work shall be completed within two-hundred and fifty-two (252) calendar days from "Notice of Proceed"; and

WHEREAS, Resolution No. #21-097 dated March 18, 2021 authorized change orders #1 and 2 to Levy Construction Company, Inc., 134 Cuthbert Blvd., Audubon, New Jersey 08618 to renovate the City of Trenton's Reading Senior Recreation Center located at 15 Ringold Street, Trenton, New Jersey 08618 in the amount of \$651,600.00; and

WHEREAS, during the performance of said contract conditions were discovered that requires additional work to bring the building to code: 1) the removal of the existing sub floor and VCT layers below the demolished top VCT Layer and 2) to extend drywall above demolished ceiling, sister joist, extend partitions to above drop ceilings at kitchenette, remove burnt ceiling above framing to extend wall to underside of deck, repair drywall on 2<sup>nd</sup> floor wall; and

NOW THEREFORE, the parties mutually agree as follows:

1. The total amount of the change orders shall be in an amount not to exceed \$12,579.22 and the total amount of the change orders are less than 20% of the original contract. will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and
2. The Mayor is hereby authorized change orders #1 and #2 with Levy Construction Company, Inc., 134 Cuthbert Blvd., Audubon, New Jersey 08618 for said purposes in the manner prescribed by law. The grand total of the project in an amount not to exceed \$651,600.00 and the change orders #1 and #2 in an amount not to exceed \$12,579.22 for a grant total of \$664,179.22.



**WHEREAS**, the total amount of the change orders are \$12,579.22 and the total amount of the change orders are less than 20% of the original contract; and


**WHEREAS**, funds have been certified to be available in T-19-20-55-5501-290.






WHEREAS, funds in an amount not to exceed \$651,600.00 have been certified in the following trust account number: T-19-20-55-5501-290.


