

**RESOLUTION # 21-137
ADDITIONAL FIVE (5) MONTH CONTRACT EXTENSION
WITH CAPITAL HEALTH SYSTEMS DBA THE CORPORATE HEALTH CENTER
CC2017-06**

THE AGREEMENT made this 29TH day of APRIL 2021, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **CAPITAL HEALTH SYSTEMS D/B/A THE CORPORATE HEALTH CENTER, 1404 WHITEHORSE-MERCERVILLE ROAD, SUITE #220, HAMILTON, NEW JERSEY 08619** (hereinafter "CONTRACTOR")

WHEREAS, Resolution Number 17-829 awarded a contract on December 21, 2017, to Capital Health Systems d/b/a The Corporate Health Center, 1404 Whitehorse-Mercerville Road, Suite #220, Hamilton, New Jersey 08619 to Provide Occupational Health Clinic Services for the City of Trenton for a period of one (1) year from January 1, 2018 to December 31, 2018 in an amount not to exceed \$235,000.00 with an option to extend two (2) one (1) year extensions for the City of Trenton, Department of Administration; and

WHEREAS, Resolution Number 19-74 exercised the option to extend the contract on February 21, 2019, for an additional one (1) year from January 1, 2019 to December 31, 2019 in an amount not to exceed \$235,000.00 to Capital Health Systems d/b/a The Corporate Health Center, 1404 Whitehorse-Mercerville Road, Suite #220, Hamilton, New Jersey 08619 to Provide Occupational Health Clinic Services and

WHEREAS, Resolution Number 20-109 exercised the option to extend the contract on March 5, 2020, for an additional one (1) year (final year) from January 1, 2020 to December 31, 2020 in an amount not to exceed \$235,000.00 to Capital Health Systems d/b/a The Corporate Health Center, 1404 Whitehorse-Mercerville Road, Suite #220, Hamilton, New Jersey 08619 to Provide Occupational Health Clinic Services for the City of Trenton, Department of Administration; and

WHEREAS, it is in the best interest of the City of Trenton, Department of Administration to authorize an additional five (5) month contract extension to Capital Health Systems d/b/a The Corporate Health Center, 1404 Whitehorse-Mercerville Road, Suite #220, Hamilton, New Jersey 08619 until a new procurement process is advertised, proposals are evaluated, approved by City Council, and a resolution and contract are in place.

WHEREAS, the City of Trenton has determined that Capital Health Systems d/b/a The Corporate Health Center, 1404 Whitehorse-Mercerville Road, Suite #220, Hamilton, New Jersey 08619 has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for an additional five (5) months to Provide Occupational Health Clinic Services for the City of Trenton, Department of Administration; and

NOW THEREFORE, the parties mutually agree as follows:


1. The amount of the agreement shall be funds in an amount not to exceed \$84,583.35 for the City of Trenton, Department of Administration for an additional five (5) months from January 1, 2021 to May 31, 2021.
2. The Mayor is hereby authorized to exercise the option to extend the contract for an additional five (5) months from January 1, 2021 to May 31, 2021 with Capital Health Systems d/b/a The Corporate Health Center, 1404 Whitehorse-Mercerville Road, Suite #220, Hamilton, New Jersey 08619 in an amount not to exceed \$84,583.35 to Provide Occupational Health Clinic Services for the City of Trenton, Department of Administration for the said purposes in the manner prescribed by law.
