WITH THE RESCUE MISSION OF TRENTON, NEW JERSEY  
CC2019-07  
TO PROVIDE EMERGENCY HOMELESS SHELTER FOR HOMELESS MEN AND WOMEN**

**THE AGREEMENT** made this 23rd day of DECEMBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **THE RESCUE MISSION OF TRENTON, LLC, 98 CARROLL STREET, P.O. BOX 790, TRENTON, NEW JERSEY 08605** (hereinafter "CONTRACTOR")

**WHEREAS**, Resolution Number 19-521 adopted a contract on October 3, 2019, awarded to The Rescue Mission of Trenton, LLC, 98 Carroll Street, P.O. Box 790, Trenton, New Jersey 08605 to Provide Emergency Homeless Shelter for Homeless Men and Women of the City of Trenton for a period of one (1) year from October 4, 2019 to October 3, 2020 in an amount not to exceed \$271,000.00 per year with an option to extend two (2) one (1) year extensions (2<sup>nd</sup> year \$279,130.00 and 3<sup>rd</sup> year \$287,503.00) for the City of Trenton, Department of health and Human Services; and

WHEREAS, Resolution Number 20-740 adopted a contract on December 22, 2020, awarded to The Rescue Mission of Trenton, LLC, 98 Carroll Street, P.O. Box 790, Trenton, New Jersey 08605 to Provide Emergency Homeless Shelter for Homeless Men and Women of the City of Trenton for a period of two (2) one (1) year extensions in an amount not to exceed \$279,130.00 from October 4, 2020 to October 4, 2021.

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

**WHEREAS**, the City of Trenton, Department of Health and Human Services, has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year from October 4, 2020 to October 3, 2021 to The Rescue Mission of Trenton, LLC, 98 Carroll Street, P.O. Box 790, Trenton, New Jersey 08605 in an amount not to exceed \$279,130.00; and

**NOW THEREFORE**, the parties mutually agree as follows:


1. The amount of the agreement shall be in an amount not to exceed \$279,130.00 with the option to extend the second (2<sup>nd</sup>) year for the City of Trenton, Department of Health and Human Services from October 4, 2020 to October 3, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for one (1) year from October 4, 2020 to October 3, 2021 with The Rescue Mission of Trenton, LLC, 98 Carroll Street, P.O. Box 790, Trenton, New Jersey 08605 in an amount not to exceed \$279,130.00 to Provide Emergency Homeless Shelter for Homeless Men and Women of the City of Trenton, Department of Health and Human Services for the said purposes in the manner prescribed by law.






**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:






