CHANGE ORDER #1 PER REGULATIONS WITH THE NEW JERSEY DEPARTMENT OF TRANSPORATION TO
DECREASE THE INITIAL CONTRACT PRICE FOR WEST STATE STREET IMPROVEMENTS FOR 2017
TRANSPORTATION TRUST FUND
BID2019-73

THE AGREEMENT made this 27th day of MAY 2021, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **RICHARD T. BARRETT PAVING COMPANY, INC., 400 PROSPECT STREET, TRENTON, NEW JERSEY 08618** (hereinafter "CONTRACTOR")

WHEREAS, Resolution 20-16 awarded a contract on January 9, 2020, to Richard T. Barrett Paving Company, Inc., 400 Prospect Street, Trenton, New Jersey 08618 for West State Street Improvements for 2017 Transportation Fund for the City of Trenton, Department of Public Works, Division of Traffic and Transportation in an amount not to exceed \$371,112.50; Work shall be completed within sixty (60) calendar days from "Notice of Proceed"; and

WHEREAS, Resolution No. #21-211 dated May 27, 2021 authorized change order #1 to Richard T. Barrett Paving Company, Inc., 400 Prospect Street, Trenton, New Jersey 08618 for a decrease in the contract price from \$371,122.50 to \$295,623.40, a decrease of \$75,499.10 or 0.20%. The decrease to the contract amount is based on an adjustment of estimated quantities to match actual quantities; and


WHEREAS, the aforesaid modification necessitates a change order to reflect the actual contract amount which the change order is permissible under Local Public Contract Law and the Local Government Services regulations with the respect to the same; and

NOW THEREFORE, the parties mutually agree as follows:

1. The total amount of the change order #1 shall be in an amount not to exceed \$75,499.10 and the total amount of the change orders is less than 20% of the original contract will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and
2. The Mayor is hereby to execute authorized change order #1 with Richard T. Barrett Paving Company, Inc., 400 Prospect Street, Trenton, New Jersey 08618 for said purposes in the manner prescribed by law. The grand total with change order #1 in an amount not to exceed \$371,122.50 for a grant total of \$112,621.60.


