

**AGREEMENT

EMERGENCY PAYMENT ON AN EMERGENCY BASIS FOR SNOW PLOWING SERVICES FOR THE DEPARTMENT OF
PUBLIC WORKS, DIVISION OF STREETS
ISSUED TO YAROS LANDSCAPES**

THE AGREEMENT made this 4TH day of FEBRUARY 2021, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **YAROS LANDSCAPES, 359 PRINCETON AVENUE, HAMILTON, NEW JERSEY 08619** (hereinafter "CONTRACTOR")

WHEREAS, a contract was awarded to Yaros Landscapes, 359 Princeton Avenue, Hamilton, New Jersey 08619 for snow plowing services for the City of Trenton, Department of Public Works, Division of Streets; and

WHEREAS, the maximum amount of the contracts was in an amount not to exceed \$152,848.08

WHEREAS, the Local Public Contract Law at N.J.S.A. 40A:11-6 provides that "[a]ny contract may be negotiated or awarded... without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety and welfare requires the immediate..."performance of services", subject to the award being made pursuant to the manner set forth therein; and

WHEREAS, the official in charge Wahab A. Onitiri, Director, Department of Public Works, submitted the attached certification that an emergency existed, and that immediate services to remedy the emergency were required; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$152,848.08 for the City of Trenton, Department of Public Works, Division of Streets.
2. The Mayor is hereby authorized to execute an emergency payment in an amount not to exceed \$152,848.08 to Yaros Landscapes, 359 Princeton Avenue, Hamilton, New Jersey 08619 for snow plowing services for the City of Trenton, Department of Public Works, Division of Streets for the said purposes in the manner prescribed by law.



RESOLUTION AUTHORIZING PAYMENT FOR A CONTRACT WITH YAROS LANDSCAPES., 359 PRINCETON AVE., HAMILTON, NJ 08619 WHICH WAS AWARDED ON AN EMERGENCY BASIS FOR SNOW PLOWING SERVICES FOR THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF STREETS IN AN AMOUNT NOT TO EXCEED \$152,848.08

WHEREAS, a contract was awarded to Yaros Landscapes, 359 Princeton Ave., Hamilton, NJ 08619 for snow plowing services for the Department of Public Works, Division of Streets; and

WHEREAS, the maximum amount of the contract was \$152,848.08 and funds have been certified to be available in Operating Account Code 1-01- -55-5521-290; and

WHEREAS, the Local Public Contracts Law at N.J.S.A. 40A:11-6 provides that "[a]ny contract may be negotiated or awarded ... without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate ... performance of services", subject to the award being made pursuant to the manner set forth therein; and

WHEREAS, the official in charge, Wahab A. Onitiri, Director, Department of Public Works, submitted the attached certification that an emergency existed, and that immediate services to remedy the emergency were required.

NOW, THEREFORE, IT IS RESOLVED by the City Council of the City of Trenton, in the County of Mercer as follows:

RESOLUTION

1. The Mayor is hereby authorized to provide payment in the amount of \$152,848.08 to Yaros Landscapes, 359 Princeton Ave., Hamilton, NJ 08619 for snow plowing services for the Department of Public Works, Division of Streets.
2. This contract was awarded without competitive bidding as an emergency pursuant to N.J.S.A. 40A:11-6 of the Local Public Contracts Law.
3. A notice of this action shall be printed once in the official newspaper for the City of Trenton, and the resolution and contract shall remain on file in the City Clerk's office.
4. The Emergency Procurement Report shall be filed with the Director of the Division of Local Government Services within 30 days pursuant to N.J.S.A. 19:44:-20.12.
