TV AND ACCESS CONTROL SYSTEMS INSTALLATION AND MAINTENANCE
WITH JIII ELECTRONICS, INCORPORATED
BID2017-61**

THE AGREEMENT made this **16th day of OCTOBER 2020**, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **JIII ELECTRONICS, INCORPORATED, 25359 MOUNT PLEASANT ROAD, COLUMBUS, NEW JERSEY 08022** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 17-640 awarded a contract on September 21, 2017, to JIII Electronics, Incorporated, 25359 Mount Pleasant Road, Columbus, New Jersey 08022 for the Repair of Burglar Alarm, Closed Circuit TV and Access Control Systems Installation and Maintenance for a period of two (2) years in amount not to exceed \$50,500.00 per year at an hourly rate of \$78.00 from September 21, 2017 to September 20, 2019 with the option to extend two (2) one (1) year options at the same hourly rate for the City of Trenton, Department of Administration; and

WHEREAS, Resolution No. 20-108 awarded an option to extend a contract on March 5, 2020, to JIII Electronics, Incorporated, 25359 Mount Pleasant Road, Columbus, New Jersey 08022 for the Repair of Burglar Alarm, Closed Circuit TV and Access Control Systems Installation and Maintenance for the third (3rd) year in amount not to exceed \$50,500.00 per year at an hourly rate of \$78.00 from September 21, 2019 to September 20, 2020 for the City of Trenton, Department of Administration; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Administration has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to exercise the fourth (4th) and final option to extend the contract for the fourth (4th) year in accordance to the bid to JIII Electronics, Incorporated, 25359 Mount Pleasant Road, Columbus, New Jersey 08022 in an amount not to exceed \$50,000.00 from October 30, 2020 to October 29, 2021; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$50,000.00 at an hourly rate of \$78.00 for the City of Trenton, Department of Administration from October 30, 2020 to October 29, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for the final year from October 30, 2020 to October 29, 2021 with JIII Electronics, Incorporated, 25359 Mount Pleasant Road, Columbus, New Jersey 08022 in an amount not to exceed \$50,000.00 at an hourly rate of \$78.00 for the Repair of Burglar Alarm, Closed Circuit TV and Access Control Systems Installation and Maintenance for the City of Trenton, Department of Administration for the said purposes in the manner prescribed by law.




