RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO SUPERION, LLC A CENTRAL SQUARE COMPANY TO PROVIDE ANNUAL MAINTENANCE AND SUPPORT FOR THE INTEGRATED PUBLIC SAFETY 911 SYSTEM FOR THE DEPARTMENT OF POLICE FOR A PERIOD OF TWO (2) YEARS FROM SEPTEMBER 1, 2022 TO AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$606,692.82 -BID2022-43

WHEREAS, one (1) sole bid was received in the Division of Purchasing on May 24, 2022, for provision, maintenance, and support services for the integrated public safety system for the Police Department, for a period of two (2) years with an option to extend two (2) years; and

WHEREAS, the bid of Superior, LLC a Central Square Company 1000 Business Center Drive, Lake Mary, FL 32746, made pursuant to advertisement, be and is hereby accepted, as the sole, responsive, responsible bidder complying with terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$606,692.82 for a period of two years have been certified to be available in the following account number (s): CY 2022, 2-01-50-5000-290, September 1, 2022–December 31, 2022 (\$101,115.48), and CY 2023, 3-01-50-5000-290, January 1, 2023–December 31, 2023 (\$303,346.44), and CY 2024, 4-01-50-5000-299, January 1, 2024– August 31, 2024 (\$202,230.90) contingent upon the adoption CY'2022, CY'2023 final budget and CY'2024 with an option to extend two (2) additional years from September 1, 2024 to August 31, 2026 in an amount not to exceed \$606,692.82. A resolution must be prepared to exercise the option to extend the contract for the two additional years and the awarded bidder must submit an extension letter holding the pricing for two additional years.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the mayor is hereby authorized to execute a contract with Superior, LLC 1000 Business Center Drive, Lake Mary, Florida 32746 to provide provision, maintenance, and support services for the integrated public safety system for the City of Trenton, Police Department for the said purposes in the manner prescribed by law.




